Notice of Rescheduled Technical and Bidders Conference

On Friday, December 13, 2024, the Louisiana Public Service Commission (“LPSC”) Staff and Entergy Louisiana LLC (“ELL”) issued a Joint Notice of Bidder and Technical Conference on the 2024 ELL Combined Cycle Combustion Turbine RFP.
