**2016 ENOI RENEWABLES RFP  
Notice of Bidders Conference**

Entergy New Orleans, Inc. (“ENOI”) has announced its intention to host a Bidders Conference for the 2016 Request for Proposals for Long-Term Renewable Generation Resources (“RFP”) on June 1, 2016. The conference will be designed to give participants a high-level overview of, and other information concerning, the RFP and related processes, and will be open to all interested persons. ENOI and Entergy Services, Inc. personnel will be available at the conference to answer questions about bidder registration, proposal submission, the proposal evaluation process, technical RFP issues, and high-level commercial terms and conditions, and to respond to other requests for information about the RFP.
